**DAILY BERTH**- use of a berth or a shore stand up to 1 day

**WEEKEND BERTH** - use of a berth or a shore stand up to 3 days

**WEEKLY BERTH** - use of a berth or a shore stand up to 7 days

**PORT PASS** - for using a berth up to 10 days during 1 year, we approve -20% discount on a daily berth if You pay the full amount in advance

**TIME OUT**- use of a berth or a shore stand up to 3 hours during the current day until till 3 PM is charged at the price of the daily berth reduced by 50%

**LONG TERM** - use of a berth or a shore stand after 3 PM during the current day is charged at the price of the daily berth

**MULTI HULL**- use of a berth or a shore stand for multihulls with maximum width up to 6.5 m is charged with +60% more of its price, for multihulls with maximum width over 6.5 m is charged with +100% more of its price

**CHECK IN**- the person who steers the vessel is obliged, immediately upon arrival of the vessel in the port, to report the arrival at the reception desk of the marina Betina and to deliver the certificate of seaworthiness as well as the list of crew members of the vessel in the port

**CHECK OUT**- the person who steers the vessel is obliged, at least one hour before the departure of the vessel from the port, to report the departure at the reception desk of the marina Betina

\* in period from 01.10. c.y. to 31.03. n.y. we approve discount of -20% on TRANSIT LOG prices

**MONTHLY BERTH**– use of a berth or a shore stand up to 1 month

**SEASONAL BERTH** – use of a berth or a shore stand up to 3 months

**WINTRY BERTH**– use of a berth or a shore stand (depending of our capacity) from the 1st October c.y. to 31st March n.y., free parking place for a car for the duration of the Berth Contract

**CAT** – berth's category is determined on the basis of the length over all (including all the additional from bow to stern) and maximum beam of the vessel

\* marina Betina reserves the right to remeasure the vessels in the port

**LOA x Bmax** - the vessels in the port whose length overall or maximum width is a whole number (e.g. 7,00 x 3,00) are charged according to the rate for subsequent higher berth category

**YACHT BOX**– crew members of the vessel in the port have the right to use connections to water and electricity (16 Ah), sanitary facilities and showers with hot water only for their personal needs

\* the use of water and electricity connections is allowed only and exclusively with the presence of the crew members on the vessel in the port or with the open Work order at the reception of Marina Betina

\* crew members on the vessel in the port are obliged to only use water hoses with a functioning connection to the tap and with a closing valve

\* the daily use of connections for electricity of 32 Ah is charged in the amount of +10% from the daily price of a berth

\* the use of water for washing the vessel in the port will be charged by the valid Price list of the marina Betina

**DRY DOCK** – use of a shore stand up to 1 year, using a cradle for placing the vessel on a land, use of 3 days berth in the sea

**SEA POINT**– use of a berth in the sea up to 1 year, 3 days use of a shore stand up and using a cradle for placing the vessel on a land

**TERRA MARIS** – use of a berth in the sea from 1st April to 30th September and use of a shore stand from 1st October c.y. to 31st March n.y., using a cradle for placing the vessel on a land

**LOYALTY BONUS**– 1% discount on the services of the marina Betina for each of the previous Annual Berth Contract but only for the yacht which is registered for personal needs – Max10%

**PARK CAR** – the users of the annual berth have the right to use the parking lot in Marina Betina for their personal vehicle along with the duration of the Berth Contract

\* Marina Betina is not responsible for damage to the vehicle and objects in the vehicle during use parking

**VALID DATE**– the Annual Berth Contract is concluded for a determined period of time, specifically from 1st April of the c.y. to 31st March of the n.y. and it is not valid after the contracted time
